ORDINANCE 2023-O-19

AN ORDINANCE TO ADOPT THE FALL 2023 AMENDMENT TO THE COMPREHENSIVE PLAN, AMENDING MAP 4.3 FUTURE LAND USE PLAN MAP, AND FIGURE 7-1: FUTURE LAND USE MAP IN THE NORTH STONER PRAIRIE NEIGHBORHOOD PLAN, FOR PROPERTY ALONG LACY ROAD IN SECTION 7, CITY OF FITCHBURG IN DANE COUNTY, WISCONSIN (QUARRY VISTA OUTLOT 2 AND OUTLOT 1 OF CSM 15053) (PARCEL NUMBERS: #225/0609-073-6500-2 AND #225/0609-0749015-2)

WHEREAS, pursuant to section 62.23(2) and (3) of the Wisconsin Statutes, the City of Fitchburg, is authorized to prepare and adopt a comprehensive plan as defined in section 66.1001(1)(a) and 66.1001(2) of the Wisconsin Statutes, and

WHEREAS, the City of Fitchburg Comprehensive Plan allows the City to process amendments no more frequently than twice per year, and

WHEREAS, the State Comprehensive Planning Law requires that the City follow the same administrative procedures for adoption defined under Wisconsin Statutes, Section 66.1001(4), to amend the Comprehensive Plan, and

WHEREAS, the City of Fitchburg has held at least one public hearing on this ordinance, in compliance with the requirements of section 66.1001(4)(d) of Wisconsin Statutes, and

WHEREAS, pursuant to section 66.1001(4)(b) and (c) of the Wisconsin Statutes, the City of Fitchburg Plan Commission, through adoption of Plan Commission Resolution PCR-05-23, has recommended the Council approve this amendment, and

WHEREAS, the City of Fitchburg Plan Commission has ensured the amendment is in full compliance with the Comprehensive Plan.

NOW, THEREFORE, the Common Council of the City of Fitchburg, Wisconsin does ordain as follows:


Section 1. The City of Fitchburg, Wisconsin, does hereby adopt the 2023 Comprehensive Plan Amendment, Amending Map 4.3 Future Land Use Plan Map, and Figure 7-1: Future Land Use Map in the North Stoner Prairie Neighborhood Plan, for property located along Lacy Road, as a parcel of land located on Outlot 2 of Quarry Vista and Outlot 1 of CSM 15053 in Section 7, City of Fitchburg, Dane County, Wisconsin (Parcel Numbers: #225/0609-073-6500-2 and #225/0609-0749015-2) from I-C (Industrial Commercial), LDR (Low Density Residential), and P&C (Parks and Conservancy) to I-G (Industrial General), LDR (Low Density Residential), and P&C (Parks and Conservancy).

Section 2. This ordinance shall take effect upon passage by a majority vote of the members-elect, as defined in Wisconsin Statute Section 59.001(2m), of the Common Council and publication/posting as required by law.
