## Security Plan

### 1. **Security Posture:**

We employ an outside security firm in distinctive attire, equipped with earpiece radio communication at all times.

Security cameras are installed both inside the premises and around the outside perimeter.

The parking lot is well-lit to cover all perimeters.

Staff/Security Personnel receive regular training on security procedures and protocols for effective handling of incidents and emergencies.

### 2. **Number of Security Personnel:**

Our approximate security-to-patron ratio is 10 to 1.

### 3. **Utilization of Staff/Security Personnel:**

Two or more security personnel are stationed at the front entrance to conduct ID and weapon checks.

Security staff rotate during peak hours, monitoring key areas like main floors, patio, bathrooms, doors, and the parking lot.

One staff member is dedicated to monitoring security cameras.

### 4. **Control and Clearing of Parking Lots:**

After the main room is cleared, additional staff join to ensure the parking lot is free of people and debris.

### 5. **Handling Unruly Patrons:**

Our Security Teams are trained to manage unruly patrons, focusing on de-escalation techniques.

### 6. **Dealing with Intoxicated Persons:**

Entrance and service are refused to intoxicated individuals as needed.

### 7. **Supervision of Patrons Under Twenty-One (21):**

No underage individuals are permitted inside the building during events from 10pm-2am. Early patrons are managed by servers, bartenders, and managers.

### 8. **Management of False IDs:**

All IDs are thoroughly checked/scanned, and any false IDs are confiscated and turned over to the police department.

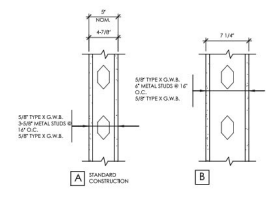
### 9. **Calling The Police:**

The Manager-On-Duty assesses situations for escalated incidents or physical aggression, deciding when to involve law enforcement.

### 10. **Handling Physical Disturbances:**

Our Security Team is trained to deescalate physical disturbances. The Manager-On-Duty makes the call during escalated situations, maintaining constant communication with the Security Team via earpiece radio devices.

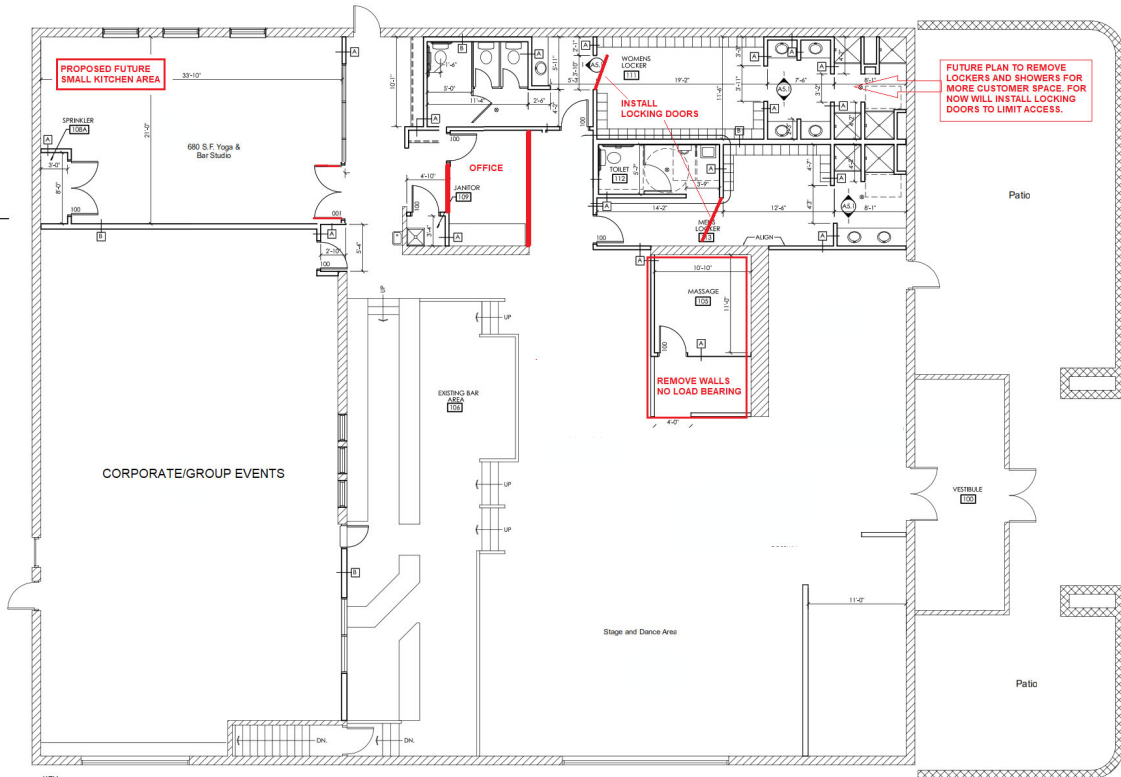
EXISTING FLOOR PLAN. PROPOSED CHANGES IN RED FOR PROPOSED USE.

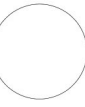
